## **Picnic Island**

After months of negotiating with Florida's Department of Environmental Protection, Calusa Land Trust signed a lease on October 13 agreeing to take over all management responsibilities for Picnic Island.

Located near St. James City adjacent to our recently purchased Sister Keys Preserve, Picnic Island will now be managed for the continued enjoyment of the boating public. The Pine Island Boat Club will be sharing management duties with us. Of top concern is the gradual replacement of the exotic trees with native ones. The exotic shade trees will remain until the native trees are big enough to provide much needed shade. Members of both the Calusa Land Trust and the Boat Club have already begun this process by planting over twenty natives in mid-July and hauling water out to the island to get them established.

We hope everyone will take the time to visit Picnic Island to see what a treasure it is. Once there, you can help out by picking up any trash you may find and hauling it back to the mainland. If you want to have a fire, you may use any wood that is left over from past maintenance work and stacked in a pile; otherwise we ask that everyone bring their own wood. With all of us keeping an eye on things and following common outdoor courtesies like taking away everything we bring, Picnic Island will only get more beautiful over time.



## President's Report

As you will quickly see, lots of good things have been happening with your Calusa Land Trust. Norm Gowan's article on Picnic Island describes a "one-of-a-kind" cooperation with the state of Florida. This is a marvelous opportunity for us to not only manage one of the jewels of southwest Florida, but also to demonstrate the power of cooperation between different organizations. Brenda Anderson's report on the Great Calusa Blueway (another joint effort, this time with Calusa Land Trust assisting Lee County), ensures that outdoor enthusiasts can more easily enjoy five of our existing preserves. Ed Chapin's Ranger/Stewardship report highlights all the ongoing activities his committee does to improve the quality of our preserves and educate the community.

To date we have been quite successful in adding new lands to be protected. Harold Bruner's acquisition committee report outlines the problems we now face in acquiring more land due to rapidly rising prices and increasing competition. This is a major challenge for the Calusa Land Trust. Therefore, I wholeheartedly recommend that you:

1. Participate in the fund-raisers described in Norm Gowan's comments below—they are a fun way to support your organization.
2. Support the endowment fund—this is important for long-term management of our preserves.
3. Finally, let us know your thoughts and ideas. We would love to hear your suggestions on how to make our organization more successful.

Eight of our directors have already been elected for the 2003–04 term (the second half of their two-year terms). This leaves two openings on the Board. The Nominating Committee has selected two excellent candidates. The first is Brenda Anderson, an enthusiastic member for many years who has given a great deal of support with her accounting, guiding, and ranger skills. Brenda recently headed up our cooperative effort with the Great Calusa Blueway. The second is Gene Tollman, a past Commodore of the Pine Island Boat Club and a co-founder of the Sailing Club. Gene has worked on several of our fundraising events and has been active in our management of Picnic Island. Additional nominations will be taken from the floor during the annual meeting.

## Blueway Report

At the July board meeting, the Calusa Land Trust board of directors voted to participate in the Great Calusa Blueway by offering five CLT preserves to be included on the blueway map and website.

The Great Calusa Blueway is a marked canoe and kayak trail sponsored by Lee County Parks and Recreation. Phase I is now complete and encompasses Estero Bay from the Imperial River to Bunche Beach. Phase II will include Matlacha Pass and Pine Island Sound and it is scheduled to be completed by March 2004.

These Calusa Land Trust preserves will be presented as "Highlights" on their map with various activities offered. (Note: it was decided that camping would not be one of these activities.)

Picnic Island will also be listed on the Great Calusa Blueway Map. This state-owned property is managed by Calusa Land Trust; in accordance with our recent agreement with the state, primitive camping will be allowed using wilderness camping etiquette.

Our CLT Blueways Committee (Harold Bruner, Ed Chapin, Joan Culver, Judy Ott, Ron Wesorick, Jack Worthington, and myself) is now in the process of marking the canoe trails on our preserves. We will start with those listed above and eventually include all of the trails that we have been using on the Peter Ordway Mangrove Water Tours. ## Acquisition Committee Report

The acquisition committee continues to pursue ways to preserve additional land in Greater Pine Island. There have been no acquisitions this fall, but two specific opportunities are being pursued. One is a donation that the owners hope to complete by the end of the year.

An interesting dilemma has come before the committee and the board. In our last CLT brochure we asked for people to contact us if they were willing to donate their land or to sell it to us at market prices. Real estate values have risen so much on Pine Island recently that there is some concern on the board about paying today's high prices. Feedback from our membership about this issue would be helpful.

At the next acquisition committee meeting we are going to continue to focus on ways of acquiring properties that are adjacent to preserves we already own. We will also be discussing an exciting new idea about acquiring certain lands that might be overlooked in this current market.

# Ranger/Stewardship Report

**Work Parties:** In July, several rangers braved the heat at Picnic Island and Sister Keys and planted about twenty trees: slash pines, mahoganies, seagrapes, buttonwoods, gumbo limbos, and live oaks. We want to get the trees in the ground before the rainy season was entirely over. Afterwards we picked up trash and headed home.

In September, we went to Big Jim Creek and Fritts Park, trimming around the trees and inching down the canoe trail removing errant branches and roots.

In October, Harold Bruner and Bud House went to Dobbs Preserve to clean up the trail and plant four 5-foot slash pines near the road. Then they went to St. Jude Trail, planting more slash pines near the entrance. At the Eagle Preserve, Brian Cotterill, Judy Ott, and I trimmed and marked the nature trail while pulling hundreds of melaleuca seedlings.

In November, the rangers once again spread out, this time to three preserves. Bud House and Harold Bruner went to Merwin Key, to “basal bark” Australian pine trees and pick up trash. Joan Culver and I boated to Picnic Island to water a newly planted live oak and two slash pines. We also picked up a bucket of trash, cut down and poisoned Brazilian peppers and Australian pines, and pulled up over 100 carrotwood seedlings. It was quite a productive day, but it was the group who kayaked to Back Bay, Jack Worthington, Brenda Anderson, and Terry and Susan Clements, who found the real surprise and ended up with a bonus to boot. Besides the usual bottles and styrofoam cups found while trash collecting, they came across a very nice inflatable dinghy with no motor. It did not take long to analyze the situation. After Brenda towed it back, a phone call to the sheriff's office confirmed their suspicions: it was stolen. The owner, who lives on Sanibel, was so grateful to get his boat back that he made a \$100 donation to the trust!

**Canoe Trail Now Open:** The canoe trail leading from Fritts Park to Big Jim Creek has been closed for over a year because of vegetative overgrowth. It is open once again, thanks especially to Pete Golling, who went out every day for a week straight, cutting and trimming the final 100 feet of the trail. Now that the cooler days are here, everyone should try to find an afternoon or morning to enjoy this beautiful trail once again.

**Mote Marine Juvenile Fish Project:** As mentioned in a previous newsletter, Calusa Land Trust has agreed to work with Mote Marine researcher Dr. Aaron Adams to monitor juvenile fish in St. James Creek, Big Jim Creek, Jug Creek, and Pine Island Creek. So far, we have gone out twice using a 35-foot seine net to trap the fish so we can measure and count them. (We have a special permit to do this, by the way.) So far we have pulled up anchovies, silversides, snook, snapper, shrimp, needlefish, pinfish, and the less familiar mohara. To make this project worthwhile, we need to go out several more times and need a few more volunteers. If you are interested, please beep me at the number above.

**Service Project:** Pine Island's Boy Scout Troop 20 volunteered to do a community service project for us. I decided to let them tackle our Back Bay Preserve and open a canoe trail. They have gone out twice and have completed the clearing process. Together we will soon mark the new trail with crab trap floats tied to branches and then create a map for our Peter Ordway Canoe Trail Guide.

**Ranger Council Meeting:** Five Rangers met on October 13 at Fritts Park and worked on setting up the next six work party dates and all canoe trips for the Peter Ordway Water Tours. They are both outlined in the table below. My hope is that in the coming year, we will continue to see our regular friends come out to work and enjoy our beautiful waterways as well as seeing many new faces.
